How to apply for business registration number ?

APPLY FOR NEW BRN

Step 1 :

1. Go to Business registration website www.br.raj.nic.in
2. Select "Apply BRN" under "Registration" menu.
3. (as shown in picture)

14. For E-Mitra & Applicants

- If BRN application is rejected, its reason may viewed by **PRINT BRN** option. BRN may be updated by **UPDATE BRN** option after rectifying the reason specified in rejection. There is no need to apply for fresh BRN.
- The facility to **UPDATE OR CANCEL BRN** online is available on portal.
